The Italian Ice Sports Federation, Ice Rink Pinè S.r.l. and Circolo Pattinatori Piné have the pleasure to invite you to take part in the following International speed-skating competition:

### **15<sup>th</sup> Masters' International Speed Skating REVIVAL 2021 Baselga di Pinè (Trento - Italy), December 11 - 12, 2021**

This competition will be held according to the under-mentioned conditions, the Regulations of the International Masters' Speed Skating Committee (IMSSC), the Regulations of the International Skating Union (ISU), and the under-mentioned conditions. This competition takes place on the 400m open-air standard speed-skating track of Ice Rink Pinè, on artificial ice. Track and Padding System are in accordance with ISU Rules. This competition is an event of the IMSSC International Masters', the International ISU's and the Italian Ice Sports Federation's 2021/2022 Calendars.

#### **1. Distances & Choices**

This is a Single Distance competition. It is open to Women and Men of the following age groups:

- Masters starting from 30 age group upward (as necessary);
- moreover, 20 and 25 age group Masters (i.e., Italian/foreign Masters and Seniors);

up to a **maximum number of 50 participants**.

Pursuant to Art. 4.2, *Single Distances and All-Round Competitions*, of Rule 4: *International Masters' Records (IMSSC Records)* of *IMSSC Constitution and Regulations*, records will be registered for all single distances (times), as well as for four-distance combinations (points). Regarding the details, please, refer to IMSSC Rules no. 4.2, 4.4.6, 3.1.1.

Skaters must choose **two distances per day**, according to the following schedule:

### Saturday December 11<sup>th</sup> 2021

500 m Women / Men;  
1.000 m Women / Men;  
1.500 m Women / Men;  
3.000 m Women / Men;  
5.000 m Women / Men.

### Sunday December 12<sup>th</sup> 2021

500 m Women / Men;  
1.000 m Women / Men;  
1.500 m Women / Men;  
3.000 m Women / Men;  
5.000m Women / Men;  
10.000 m Women / Men.

Rankings for all distances and age groups are formed based on the best times achieved by each skater in the chosen distances. Upon decision of the Referee and the O.C., quartet starts may be used in every distance.

## 2. Age Groups

This competition takes place based on the following five-year age groups (**AG** = five-year age groups Masters, Women and Men, according to their birth date, as indicated hereunder):

## 3. Eligibility

To be eligible, a skater must be a member of a National Speed Skating Federation recognized by the ISU and must have a license of his/her Federation.



#### **4. Drawing & Classification**

Neighbored five-year age groups with a small number of participants may be combined for drawing and racing (in these combined age groups, the age group of each skater will be written in the protocol, after his/her name). In spite of that, each five-year age group has its own classification, independent of its number of participants. The athlete who completes his/her trial in each single distance and obtains the best time in his/her age group wins that distance.

#### **5. Prizes and Results**

Any competitor who successfully completes the competition without being disqualified obtains a medal and a protocol containing the complete set of results, including lap times, accumulated lap times and end times. Results will be available in the Organizers' web-site: [www.icerinkpine.it](http://www.icerinkpine.it).

#### **6. Doping control**

Anti-doping tests may be effected, in accordance with ISU Rule 139.

#### **7. Liability**

In Accordance with ISU Rule 119, ISU, IMSSC and the Organizing Committee assume **no responsibility for, or liability with respect to, bodily or personal injury, or property damages**, incurred in connection with this competition. Each skater or accompanying person is solely responsible for providing insurance coverage thereto.

## 10. Registration fee

The registration fee is fixed in **€50.00 per person**.

The registration fee has to be paid at the ice-rink administrative office, before drawing. **A Registration Form (annex 1) and a Covid-19 Declaration (annex 2) must also be signed and presented together with the payment, which is herewith attached.**

The Welcome Drink is included in the registration fee.

The Common Dinner is **free of charge for Hotel Olimpico guests**. For guests of other hotels, the price is **€20.00 per person**, to be paid at the Ice-Rink administrative office before drawing.

## 11. Competition's Covid-19 Protocol

The Competition will be held under FISG Long Track Covid-19 Protocol, that will be published as annex 3 of this announcement not later than November 4<sup>th</sup>, 2021.
